RESOLUTION 20-R-14

A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH WILLIAM BERGMAN FOR COMMERCIAL BUILDING PLAN REVIEW IN THE AMOUNT OF \$80.00/HR ON AS NEEDED BASIS

The resolution, which bears the foregoing title, was unanimously adopted Monday, March 16, 2020, by the Council of the City of Vandalia. It waives the formal bidding process and authorizes the City Manager to enter into a contract with William Bergman for commercial building plan review in the amount of \$80.00/hr on as needed basis. It awards the bid for asphaltic concrete, requested by the Public Works Department, to Barrett Paving Materials in the amount of \$66.00/ton for Type II asphalt and \$67.00/ton for Type I asphalt as the lowest and best bid. It awards the bid for equipment and complete equipment installation for two police patrol vehicles, and one command vehicle requested by the Division of Police, to K. E. ORDINANCE 20-06

AN ORDINANCE AUTHORIZING AN ADJUSTMENT TO THE BOUNDARY LINE BETWEEN THE CITY OF VANDALIA, OHIO AND THE CITY OF DAYTON, OHIO BY AGREEMENT OF BOTH MUNICIPALITIES, PURSUANT TO OHIO REVISED CODE SECTION 709.37 AND DECLARING AN EMERGENCY

This ordinance authorizes an adjustment to the boundary line between the City of Vandalia, Ohio and the City of Dayton, Ohio by agreement of both municipalities, pursuant to Ohio Revised Code Section 709.37 and declaring an emergency.
