RESOLUTION 19-R-59

A RESOLUTION APPROVING THE NEW LIFE WORSHIP CENTER PLAT

The resolution, which bears the foregoing title, was unanimously adopted Monday, December 16, 2019, by the Council of the City of Vandalia. It approves the New Life Worship Center plat. ORDINANCE 19-31

AN ORDINANCE REZONING 7.73 ACRES OF PROPERTY COMMONLY KNOWN AS PART OF 3320 BENCHWOOD ROAD FROM RESIDENTIAL SINGLE-FAMILY 1 TO GATEWAY BUSINESS AND AMENDING THE ZONING MAP OF THE CITY

The ordinance, which bears the foregoing title, was unanimously approved in its second reading Monday, December 16, 2019, by the Council of the City of Vandalia. This ordinance rezones 7.73 acres of property commonly known as part of 3320 Benchwood Road from Residential Single-Family 1 to Gateway Business and amends the zoning map of the city.
