RESOLUTION NO 19-R-03

A RESOLUTION AUTHORIZING A BONUS TO THE CITY MANAGER

RESOLUTION 19-R-04

A RESOLUTION AUTHORIZING THE PURCHASE OF A 2019 INTERNATIONAL HEAVY DUTY CHASSIS MEDIC, REQUESTED BY THE FIRE DIVISION, TO HORTON EMERGENCY VEHICLES FOR THE STATE BID AMOUNT OF \$263,590.00 AND DECLARING THE EXISTING 2008 FORD E350 MEDIC AS SURPLUS PROPERTY
