RESOLUTION 19-R-23

A RESOLUTION DECLARING VARIOUS ITEMS AS SURPLUS AND AUTHORIZING DISPOSAL OF SUCH ITEMS

ORDINANCE 19-05

AN ORDINANCE AMENDING THE VANDALIA ZONING CODE TABLE 1224-2: PERMITTED ACCESSORY USES AND STRUCTURES, AND CITY CODE SECTION 1224.01(E) "STANDARDS FOR SPECIFIC ACCESSORY USES AND STRUCTURES", TO PERMIT THE RAISING OF CHICKENS

The ordinance, which bears the foregoing title was unanimously approved in its first reading Monday, April 15, 2019, by the Council of the City of Vandalia. It amends the Vandalia Zoning Code Table 1224-2: Permitted Accessory Uses and Structures, and city code section 1224.01(E) "Standards for Specific Accessory Uses and Structures", To Permit the Raising of Chickens. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the Council of the City of Vandalia, Ohio on Monday, May 6, 2019 at 7:00 p.m., in Council Chambers, 333 J.E.
