### RESOLUTION 18-R-61

**A RESOLUTION AWARDING THE BID FOR THE ASPHALT & CONCRETE MAINTENANCE PROJECT AT THE MUNICIPAL BUILDING, SPORTS COMPLEX, RECREATION CENTER, AND FACILITY MAINTENANCE GARAGE TO A TO Z ASPHALT CONTRACTORS, INC., AT THE LOWEST AND BEST BID PRICE OF \$67,836**

The resolution which bears the foregoing title was unanimously adopted Monday, October 1, 2018, by the Council of the City of Vandalia. It awards the bid for the asphalt & concrete maintenance project at the Municipal Building, Sports Complex, Recreation Center, and Facility Maintenance Garage to A to Z Asphalt Contractors, Inc., at the lowest and best bid price of \$67,836. It extends the limited temporary moratorium on the acceptance, consideration and/or granting of any applications for zoning regarding shooting grounds or ranges and issuance of permits to discharge firearms as related to such uses within the City of Vandalia. It authorizes the city manager to negotiate and enter into agreements with Tyler Technologies for finance software and for a time management system and associated maintenance agreements in the total amount of \$313,852. ### ORDINANCE 18-20

**AN ORDINANCE APPROVING A MAJOR AMENDMENT FOR THE PROPERTIES LOCATED AT 14 AND 16 CLUBHOUSE WAY AND OWNED BY SWAFFORD CONSTRUCTION COMPANY, IN THE RESIDENTIAL SINGLE-FAMILY 3 DISTRICT WITH A PUD OVERLAY**

The ordinance, which bears the foregoing title was approved in its second reading by a vote of 6-0 with 1 abstention Monday, October 1, 2018, by the Council of the City of Vandalia. It approves a major amendment for the properties located at 14 and 16 Clubhouse Way and owned by Swafford Construction Company, in the Residential Single-Family 3 District with a PUD overlay.
