#### **RESOLUTION 18-R-69**

AN ORDINANCE REZONING THE PROPERTY GENERALLY LOCATED AT THE NORTHWEST CORNER OF MILLER LANE AND STOP EIGHT ROAD FROM RESIDENTIAL SINGLE-FAMILY 1 "RSF-1" TO HIGHWAY BUSINESS "HB" AND AMENDING THE ZONING MAP OF THE CITY
