RESOLUTION NO 18-R-76

A RESOLUTION AUTHORIZING THE PURCHASE OF A JOHN DEERE 4066R COMPACT UTILITY TRACTOR REQUESTED BY THE PARKS AND RECREATION DEPARTMENT, FROM BOONE'S POWER EQUIPMENT, INC. AT THE STATE OF OHIO CONTRACT BID PRICE OF \$39,649.29

The resolution which bears the foregoing title was unanimously adopted Monday, December 17, 2018, by the Council of the City of Vandalia. It authorizes the purchase of a John Deere 4066R compact utility tractor requested by the Parks and Recreation Department, from Boone's Power Equipment, Inc. at the State of Ohio contract bid price of \$39,649.29.
