



## Summary of Legislation – City of Vandalia

### ORDINANCE 18-01

**AN ORDINANCE AMENDING THE VANDALIA ZONING CODE SECTIONS 1231.02 “TERMS DEFINED”, AND 1262.04 “CONDITIONALLY PERMITTED USES, IN THE HIGHWAY BUSINESS DISTRICT” AND ADDING SECTION 1276.36 “EQUIPMENT RENTAL” TO CHAPTER 1276 SUPPLEMENTAL REGULATIONS, TO PROVIDE FOR EQUIPMENT RENTAL**

The ordinance which bears the foregoing title was unanimously adopted in its second reading Monday, February 5, 2018, by the Council of the City of Vandalia. It approves the Vandalia Zoning Code Sections 1231.02 “terms defined”, and 1262.04 “conditionally permitted uses, in the Highway Business District” and adding section 1276.36 “equipment rental” to chapter 1276 supplemental regulations, to provide for equipment rental. ### RESOLUTION NO. 18-R-10

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH MONTGOMERY COUNTY BOARD OF COUNTY COMMISSIONERS FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FOR CONCRETE REPAIR WORK INCLUDING INSTALLATION OF HANDICAP RAMPS AND STREET RESURFACING OF VARIOUS STREETS**

The resolution, which bears the foregoing title, was unanimously adopted on Monday, February 5, 2018 by the Council of the City of Vandalia. It authorizes the city manager to execute an agreement with Montgomery County Board of County Commissioners for Community Development Block Grant (CDBG) funds for concrete repair work including installation of handicap ramps and street resurfacing of various streets. ### RESOLUTION 18-R-11

**A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH PACE ANALYTICAL SERVICES, INC TO PROVIDE EPA MANDATED SAMPLING AND TESTING OF SANITARY SEWER DISCHARGE FROM VARIOUS INDUSTRIES AND BACTERIA TESTING OF DRINKING WATER IN THE CITY OF VANDALIA FOR CALENDAR YEAR 2018**

The resolution, which bears the foregoing title, was unanimously adopted on Monday, February 5, 2018 by the Council of the City of Vandalia. It waives the formal bidding process and authorizes the city manager to enter into a contract with Pace Analytical Services, Inc. to provide EPA mandated sampling and testing of sanitary sewer discharge from various industries and bacteria testing of drinking water in the city of Vandalia for calendar year 2018. ### RESOLUTION 18-R-12

**A RESOLUTION AUTHORIZING THE PURCHASE OF A 2018 ELGIN CROSSWIND STS STREET SWEEPER REQUESTED BY THE PUBLIC WORKS DEPARTMENT FROM JACK DOHENY COMPANIES IN THE AMOUNT OF THE STATE BID PRICE AND DECLARING THE CURRENT 2007 ALLIANCE/JOHNSON STREET SWEEPER TO BE REPLACED AS SURPLUS PROPERTY**

The resolution, which bears the foregoing title, was unanimously adopted on Monday, February 5, 2018 by the Council of the City of Vandalia. It authorizes the purchase of a 2018 Elgin Crosswind STS street sweeper requested by the Public Works Department from Jack Doheny Companies in the amount of the state bid price and declaring the current 2007 Alliance/Johnson street sweeper to be replaced as surplus property.
