#### **RESOLUTION 18-R-17**

A RESOLUTION AUTHORIZING THE PURCHASE OF A TORO GREENSMASTER 3150-Q, REQUESTED BY THE PARKS AND RECREATION DEPARTMENT, THROUGH CENTURY EQUIPMENT OF CINCINNATI AT THE STATE OF OHIO CONTRACT BID PRICE OF \$32,669.39 AND REQUESTING COUNCIL DECLARE THE CURRENT 2003 TORO GREENSMASTER 3150 MOWER BEING REPLACED SURPLUS PROPERTY

The resolution which bears the foregoing title was unanimously adopted Monday, February 19, 2018, by the Council of the City of Vandalia.
