RESOLUTION 18-R-27

A RESOLUTION AWARDING THE BID FOR THE OVERHEAD DOOR REPLACEMENT PROJECT, REQUESTED BY THE DIVISION OF FIRE, TO HIGHFIELD DOOR SALES IN THE AMOUNT OF \$14,995
