### **RESOLUTION 17-R-20**

# A RESOLUTION WAIVING THE FORMAL BIDDING REQUIREMENT AND AUTHORIZING CERTAIN SERVICES FROM DH PRODUCTIONS DURING THE 2017 CALENDAR YEAR

The resolution, which bears the foregoing title, was unanimously adopted on Monday, February 20, 2017 by the Council of the City of Vandalia. It waives the formal bidding requirement and authorizes certain services from DH Productions during the 2017 calendar year. ### **RESOLUTION 17-R-22**

A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH MONTGOMERY COUNTY BOARD OF COUNTY COMMISSIONERS FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FOR CONCRETE REPAIR WORK INCLUDING INSTALLATION OF HANDICAP RAMPS AND STREET RESURFACING OF VARIOUS STREETS

The resolution, which bears the foregoing title, was unanimously adopted on Monday, February 20, 2017 by the Council of the City of Vandalia. It authorizes the city manager to execute an agreement with Montgomery County Board of County Commissioners for Community Development Block Grant (CDBG) Funds for concrete repair work including installation of handicap ramps and street resurfacing of various streets. ## **RESOLUTION 17-R-23**

A RESOLUTION STRONGLY OPPOSING THE PROVISION WITHIN THE STATE OF OHIO GOVERNOR'S PROPOSED 2018-2019 BUDGET, WHICH PROPOSES CENTRALIZED COLLECTION OF NET PROFIT TAX RETURNS AND OTHER PROVISIONS RELATED TO THE MUNICIPAL INCOME TAX WHICH WILL CAUSE A SUBSTANTIAL LOSS OF REVENUE NEEDED TO SUPPORT THE HEALTH, SAFETY, WELFARE AND ECONOMIC DEVELOPMENT EFFORTS OF OHIO MUNICIPALITIES

The resolution, which bears the foregoing title, was unanimously adopted on Monday, February 20, 2017 by the Council of the City of Vandalia. It strongly opposes the provision within the State of Ohio Governor's Proposed 2018-2019 Budget, which proposes centralized collection of net profit tax returns and other provisions related to the municipal income tax which will cause a substantial loss of revenue needed to support the health, safety, welfare and economic development efforts of Ohio municipalities. ### **ORDINANCE 17-05**

AN ORDINANCE APPROVING A PLANNED UNIT DEVELOPMENT FINAL DEVELOPMENT PLAN FOR LOT 2 OF THE "40 WEST" DEVELOPMENT, FORMERLY REFERRED TO AS THE "VANDALIA OFFICE PARK" AND LOCATED AT 235 W. NATIONAL ROAD
