RESOLUTION 17-R-24

A RESOLUTION AWARDING THE BID FOR ASPHALTIC CONCRETE, REQUESTED BY THE PUBLIC WORKS DEPARTMENT, TO VALLEY ASPHALT CORP. IN THE AMOUNT OF \$67.00/TON FOR TYPE II ASPHALT AND \$68.00/TON FOR TYPE I ASPHALT AS THE LOWEST AND BEST BID

It awards the bid for asphaltic concrete, requested by the Public Works Department, to Valley Asphalt Corp. in the amount of \$67.00/ton for Type II Asphalt and \$68.00/ton for Type I Asphalt as the lowest and best bid.
