RESOLUTION 16-R-95

A RESOLUTION AUTHORIZING COOPERATION AND CONTRACTS WITH OHIO DEPARTMENT OF TRANSPORTATION REGARDING THE MILL AND RESURFACING ON AIRPORT ACCESS ROAD, PID NO. 103062

ORDINANCE 16-33

AN ORDINANCE APPROVING A MAJOR AMENDMENT TO THE PLANNED UNIT DEVELOPMENT FOR THE PROPERTY LOCATED AT 400 NATIONAL ROAD AND OWNED BY MAX'S SPORTS AND SPIRITS INC., IN THE DOWNTOWN BUSINESS DISTRICT WITH A PUD OVERLAY

The ordinance for the PUD amendment was approved 4-3 subject to the applicant providing a plexi-glass type buffer within the proposed patio on the side that is adjacent to the KFC drive thru. It approves a major amendment to the planned unit development for the property located at 400 National Road and owned by Max's Sports and Spirits Inc., in the Downtown Business District with a PUD overlay.
