RESOLUTION 16-R-97

A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE PURCHASE OF VARIOUS HARDWARE AND SOFTWARE COMPONENTS FOR THE 2016 SERVER UPGRADE PROJECT AT A TOTAL PRICE OF \$168,598.45
