RESOLUTION 16-R-03

A RESOLUTION APPROVING THE PLAT OF BUNKERS SPORTS BAR AND GRILL, LLC.

The resolution, which bears the foregoing title, was unanimously adopted on Tuesday, January 19, 2016 by the Council of the City of Vandalia. It approves the plat of Bunkers Sports Bar and Grill, LLC. being a plat of parcel B02 00127 0018 and B02 00127 0017, creating 1 lot, consisting of 1.261 acres and dedicating 0.159 acres of public right-of-way, located at 893 East National Road in the City of Vandalia and Section 15, Town 3, Range 6 East, Montgomery County, Ohio, and part of a lot owned by Bunkers Sports Bar and Grill, LLC., as conveyed in IR Deed 14-050586 and 11-046338 of the Montgomery County Deed Records. A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE PURCHASE OF ONE 2016 KME RESCUE FIRE ENGINE FROM WARREN FIRE EQUIPMENT IN THE AMOUNT OF THE STATE BID PRICE OF \$489,814 AND DECLARING THE 1979 EMERGENCY ONE FIRE ENGINE BEING REPLACED SURPLUS PROPERTY

ORDINANCE 16-01

ORDINANCE AUTHORIZING A TEMPORARY ADVANCE AND REIMBURSEMENT BETWEEN VARIOUS FUNDS OF THE CITY FOR EXPENSES RELATING TO THE PURCHASE OF A NEW RESCUE-FIRE ENGINE AND DECLARING AN EMERGENCY

The ordinance which bears the foregoing title was unanimously adopted as an emergency measure on Tuesday, January 19, 2016, by the Council of the City of Vandalia for the immediate preservation of the peace, health, safety, and welfare of the citizens of the City of Vandalia and for the further that it is imperative to keep City financial records in order. It authorizes a temporary advance and reimbursement between various funds of the city for expenses relating to the purchase of a new rescue-fire engine and declaring an emergency.
