RESOLUTION 16-R-12

A RESOLUTION WAIVING THE FORMAL BIDDING REQUIREMENT AND AUTHORIZING CERTAIN SERVICES FROM DH PRODUCTIONS DURING THE 2016 CALENDAR YEAR

The resolution, which bears the foregoing title, was unanimously adopted on Monday, February 15, 2016 by the Council of the City of Vandalia. The resolution waives the formal bidding requirement and authorizes certain services from DH Productions during the 2016 calendar year. A RESOLUTION APPROVING A FUTURE LAND USE AMENDMENT TO THE COMPREHENSIVE PLAN BY DESIGNATING FUTURE LAND USE CATEGORIES FOR TWO HUNDRED SEVENTEEN PARCELS GENERALLY LOCATED NORTH OF LITTLE YORK ROAD, SOUTH OF I-70 AND EAST OF I-75 TO THE CITY LIMIT

The resolution approves a future land use amendment to the comprehensive plan by designating future land use categories for two hundred seventeen parcels generally located north of Little York Road, south of I-70 and east of I-75 to the city limit.
