AN ORDINANCE DISSOLVING THE HUMAN RELATIONS COMMISSION AND AMENDING SECTIONS 632.01(a), 632.02(a)(10), AND REPEALING CHAPTER 272 AND SECTIONS 632.07, 08, 09, 10, 11, 12, and 13 OF THE CODIFIED ORDINANCES OF VANDALIA, OHIO TO REMOVE THE REFERENCES TO THE HUMAN RELATIONS COMMISSION FROM THE CODIFIED ORDINANCES
