

Council Action

In an effort to increase awareness and understanding, this publication was created to detail and explain the actions of the Vandalia City Council. We hope this promotes a better understanding of the role Council plays in keeping Vandalia a great place to live, work and play.

Council took the following actions at the Monday, March 2 meeting:

- ✓ Approved Resolution 20-R-10, authorizing the purchase of 13 ruggedized mobile computers utilized in police vehicles to access maps, dispatch data, mobile reporting, dash cameras, and other various resources. The IT Department solicited quotes from three vendors for 13 Panasonic Toughbooks with ARC Acquisitions US, Inc. providing the lowest quote of \$43,145.57.
- ✓ Approved Resolution 20-R-11, authorizing the City Manager to enter into an agreement with Montgomery County and Xerion Advanced Battery for a \$450,000 Economic Development/Government Equity (ED/GE) award. Xerion proposes to invest \$21,000,000 toward the renovation of the former Delphi/Mahle building.
- ✓ Approved Resolution 20-R-12, authorizing a letter of understanding with the US Air and Trade Show. Per the terms of the Letter, the City agrees to provide Police and City services in direct support of the Vec-tren/Dayton Air Show being held this year on June 27th & 28th. The City will be reimbursed should such services exceed \$21,900. In return, the City will receive one Flight Line Chalet with 200 Chalet tickets for each day of the Air Show, along with catering services, which we use to host our businesses.
- ✓ Approved Resolution 20-R-13, awarding the bid for the engineering and design of the Northwoods Blvd/Falls Creek Drive Improvement Project to Choice One Engineering for \$36,500. This project involves the extension of the south lane of eastbound Northwoods Blvd and the installation of a traffic signal at the Northwoods Blvd/Falls Creek Drive intersection.
- ✓ Approved in its first reading Ordinance 20-04, amending the traffic code to give police officers the authority to cite a driver or owner for expired plates or registration. It was recently discovered that our local ordinance regarding “expired plates” was inadvertently removed from the Codified Ordinance during the last update.
- ✓ Approved a variance at 349 North American Boulevard to permit a maximum impervious surface coverage of 45.32% in order to construct a home addition.
- ✓ Approved two sign variances at 6196 Poe Avenue (Scene 75) to permit the addition of a 103 square foot wall sign and a 65.25 square foot, 9-feet tall “directional” sign.
- ✓ Approved a variance at 1100 W. National Road (Beau Townsend Nissan) to permit an on an interior lot with two curb openings.
