RESOLUTION 21-R-58

A RESOLUTION AUTHORIZING THE PURCHASE OF A 2022 INTERNATIONAL HV507 TANDEM CAB & CHASSIS BY THE PUBLIC WORKS DEPARTMENT, FROM RUSH TRUCK CENTERS AT THE STATE BID CONTRACT PRICE IN THE AMOUNT OF \$92,295.37 AND DECLARING THE CURRENT 2007 FREIGHTLINER TANDEM DUMP TRUCK & ASSOCIATED EQUIPMENT TO BE REPLACED AS SURPLUS PROPERTY

The resolution, which bears the foregoing title, was unanimously approved Tuesday, September 7, 2021, by the Council of the City of Vandalia. The resolution authorizes the purchase of a 2022 International HV507 tandem cab & chassis by the Public Works Department, from Rush Truck Centers at the state bid contract price in the amount of \$92,295.37 and declaring the current 2007 Freightliner tandem dump truck & associated equipment to be replaced as surplus property. ORDINANCE 21-26

AN ORDINANCE REZONING 6.8581 ACRES OF LAND LOCATED AT 3325 STOP EIGHT ROAD FROM HIGHWAY BUSINESS (HB) TO INDUSTRIAL (I) AND AMENDING THE ZONING MAP OF THE CITY

The ordinance, which bears the foregoing title, was unanimously approved in the first reading Tuesday, September 7, 2021, by the Council of the City of Vandalia. It rezones 6.8581 acres of land located at 3325 Stop Eight Road from Highway Business (HB) to Industrial (I) and amending the zoning map of the City. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the Council of the City of Vandalia, Ohio on Monday, September 20, 2021 at 7:00 p.m., in Council Chambers, 333 J.E.
