RESOLUTION 22-R-18

A RESOLUTION AWARDING THE BID FOR THE SCBA COMPRESSOR & FILL STATION PROJECT, REQUESTED BY THE DIVISION OF FIRE, TO BREATHING AIR SYSTEMS IN THE AMOUNT OF \$46,769.74 AS THE LOWEST AND BEST BID AND DECLARING THE CURRENT BREATHING AIR COMPRESSOR AND FILL STATION SURPLUS
