

Council Action

Council took the following actions at the Monday, May 16th meeting:

- ▼ Mayor Herbst presented a proclamation to Brady Schneider, Ashley Arnett, and Jackson Clark who will be competing in the Ohio Special Olympics Summer Games in June.
- ▼ Mayor Herbst presented a proclamation to Director of Public Service, Rob Cron, to commemorate Public Works Week.
- ▼ City Manager Wendt administered the oath of office to Firefighter Cory Brand.
- ▼ Approved Resolution 22-R-39 authorizing a \$15,000 donation to the Historical Society of Vandalia-Butler.
- ▼ Approved Resolution 22-R-40 authorizing the City Manager to waive formal bidding and enter into an agreement with Choice One Engineering for the engineering and preparation of construction drawings for the new traffic signal at Northwoods and I-75 southbound ramps in the amount of \$35,600.
- ▼ Approved Resolution 22-R-41 authorizing the City Manager to apply for ODNR Nature Works Grant funds for the construction of an accessible restroom at Robinette Park.
- ▼ Approved, in its first reading, Ordinance 22-22 authorizing the renewal of a Land Acquisition Note issued for the Stonequarry Crossings land.
- ▼ Approved in its first reading, Ordinance 22-23 authorizing the issuance of Bond Anticipation Notes for the 2016 fire engine.
- ▼ Approved, in its first reading, Ordinance 22-24 to rezone Stonequarry Crossings from Planned Unit Development to Office/Industrial Park and Public Facilities.
- ▼ Approved, in its second reading, Ordinance 22-16 amending Section 678.10 of the Codified Ordinances relating to the discharge of fireworks.
- ▼ Approved, in its second reading, Ordinance 22-17 amending the City's Zoning Code to prohibit the manufacturing and wholesaling of 1.3G and 1.4G fireworks, and to prohibit the retail sales of 1.3G and 1.4G fireworks (excluding novelties, trick noise makers, & wire sparklers).

Continued...Council took the following actions at the Monday, May 16th meeting:

- ▼ Tabled, in its second reading, Ordinance 22-18 a request to rezone 3324 Benchwood Road from Gateway Business to Highway Business.
- ▼ Approved, as an emergency, Ordinance 22-19 assessing properties for delinquent accounts related to storm water fees, trash collection, and delinquent sewer & water.
- ▼ Approved, as an emergency, Ordinance 22-20 a supplemental appropriation.
- ▼ Approved, as an emergency, Ordinance 22-21 to provide for the issuance and sale of bonds in the maximum principal amount of \$7,500,000 for the purpose of paying for the costs of improving the municipal public transportation system (e.g., roadways), including Capstone Way, Fieldstone Way, Airport Access Road and Dog Leg Road, by constructing, reconstructing, extending, opening, widening, grading, draining, curbing, paving and resurfacing, and site preparation, installing storm water, sanitary sewer and water improvements, and acquiring any necessary interests in real property, together with all incidental work and related appurtenances thereto, and declaring an emergency. Debt service for this project will likely be paid from infrastructure fees and tax increment financing associated with development, and utility revenues. This project is not likely to result in direct general fund expenditures.
