

Council Action

In an effort to increase awareness and understanding, this publication was created to detail and explain the actions of the Vandalia City Council. We hope this promotes a better understanding of the role Council plays in keeping Vandalia a great place to live, work and play.

Council took the following actions at the Monday, June 20 meeting:

- ✔ Mayor Herbst presented a proclamation to Mr. Al Tuttle in celebration of Pollinator Week, which is June 22 through June 26, 2022.
- ✔ Fire Chief Follick presented the Civilian Medal of Honor to Ms. Katie Williams.
- ✔ Approved reappointments to various Boards and Commissions.
- ✔ Approved Resolution 22-R-42 authorizing the City Manager to enter into an agreement for stop loss coverage with Nationwide for the City's healthcare renewal.
- ✔ Approved Resolution 22-R-43 awarding the contract for the Dog Leg Road Water & Sanitary Sewer Extension Phase I to Outdoor Enterprise, LLC. at the lowest and best bid price of \$3,899,947.70.
- ✔ Approved Resolution 22-R-44 authorizing the City Manager to enter into an agreement with Choice One Engineering for the Engineering and Design of the Dog Leg Road Water & Sanitary Sewer Phase II project at a cost of \$150,700. This project will extend water and sanitary sewer service to properties from Dog Leg Road to the western boundary of the City.
- ✔ Approved Resolution 22-R-45 authorizing the City Manager to enter into an addendum to the agreement with SwimSafe Pool Management. This includes an increase of \$21,931 at the Vandalia Recreation Center and \$22,100 at Cassel Hills Pool. This increase will help offset higher lifeguard wages as a result of recruitment challenges and escalating chemical prices.
- ✔ Approved Resolution 22-R-46 authorizing the City Manager to negotiate and enter into a purchase and sale agreement for land located at 9435 Dixie Drive.
- ✔ Approved Resolution 22-R-47 authorizing the City Manager to negotiate and enter into a purchase and sale agreement for certain land located in Stonequarry Crossings.
- ✔ Approved, in its second reading, Ordinance 22-18 rezoning .996 acres of land located at 3324 Benchwood Road from Gateway Business to Highway Business.
- ✔ Approved, in its second reading, Ordinance 22-24 rezoning 163 acres of land in Stonequarry Crossings from Planned Unit Development to Office/Industrial Park and Public Facilities.
- ✔ Approved, as an emergency, Ordinance 22-22 approving a payment of debt of the Land Acquisition Note for Stonequarry Crossings. The debt is scheduled to be paid in full in 2036.
- ✔ Approved, as an emergency, Ordinance 22-23 approving Bond Anticipation Notes for the 2016 Fire Engine and the 2021 Ladder Truck. This debt is scheduled to be paid in full in 2026 and 2031.
- ✔ Tabled Emergency Ordinance 22-25 which would direct the Montgomery County Board of Elections to place residential gas aggregation of the November 8, 2022 ballot.
- ✔ Tabled Emergency Ordinance 22-26 which would direct the Montgomery County Board of Elections to place residential electric aggregation on the November 8, 2022 ballot.
- ✔ Approved a variance at 7615 Poe Avenue to allow a 6-foot-tall chain link fence with a 12" barbed wire top with two conditions.
- ✔ Denied a Conditional Use Permit for a vehicle washing establishment on property located at 3324 Benchwood Road.
