RESOLUTION 22-R-54

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AUTOMATIC MUTUAL AID RESPONSE AGREEMENT WITH THE CITY OF DAYTON WITH RESPECT TO THE DAYTON INTERNATIONAL AIRPORT AND SURROUNDING COMMERCIAL/INDUSTRIAL AREAS

The resolution, which bears the foregoing title, was unanimously approved Tuesday, September 6, 2022, by the Council of the City of Vandalia. It authorizes the City Manager to enter into an Automatic Mutual Aid Response agreement with the City of Dayton with respect to the Dayton International Airport and surrounding commercial/industrial areas.
