ORDINANCE 22-44

AN ORDINANCE REZONING APPROXIMATELY 13.4 ACRES OF LAND LOCATED AT 7249 NORTH DIXIE DRIVE FROM HIGHWAY BUSINESS (HB) TO INDUSTRIAL (I) AND AMENDING THE ZONING MAP OF THE CITY

The ordinance, which bears the foregoing title, was denied 6-0, with one abstention, in the second reading Monday, December 19, 2022, by the Council of the City of Vandalia. It would have rezoned approximately 13.4 acres of land located at 7249 North Dixie Drive from Highway Business (HB) to Industrial (I) and amending the zoning map of the City.
