

Council Action

In an effort to increase awareness and understanding, this publication was created to detail and explain the actions of the Vandalia City Council. We hope this promotes a better understanding of the role Council plays in keeping Vandalia a great place to live, work and play.

Council took the following actions at the Monday, March 6, 2023, meeting:

- ✔ Held a second public hearing regarding the Miami Valley Communications Council Electric Aggregation Program.
- ✔ Held a second public hearing regarding the Miami Valley Communications Council Natural Gas Aggregation Program.
- ✔ Opted to hold no hearing for the liquor permit transfer from Challenger Ohio LTD, DBA Shen's Szechuan and Sushi to Challenge Dayton, LLC, DBA Shen's Szechuan and Sushi.
- ✔ Approved Resolution 23-R-12 authorizing the purchase of department issued handguns for the Division of Police from L.E.P.D. in the amount of \$30,706.22. These will replace firearms purchased in 2007 which will be traded in.
- ✔ Approved Resolution 23-R-13 awarding the bid for the Airport Access Road northbound bridge deck rehabilitation project to Brumbaugh Construction in the amount of \$360,000 with an extra 10% for contingency items/change orders.
- ✔ Approved Resolution 23-R-14 awarding the asphalt purchase bid to Valley Asphalt at the submitted price of \$80/ton for base asphalt and \$85/ton for surface course asphalt.
- ✔ Approved Resolution 23-R-15 adopting the Plan of Operation and Governance for the City's Electric Aggregation Program in conjunction with the Miami Valley Communications Council Electric and Natural Gas Aggregation Program.
- ✔ Approved Resolution 23-R-16 adopting the Plan of Operation and Governance for the City's Natural Gas Aggregation Program in conjunction with the Miami Valley Communications Council Electric and Natural Gas Aggregation Program.
- ✔ Approved Resolution 23-R-17 authorizing a letter of understanding with the US Air and Trade Show for police and city services in direct support of the 2023 CenterPoint Energy Air Show.
- ✔ Approved Resolution 23-R-18 approving the renaming of Veterans Memorial Parkway to Veterans Parkway.
- ✔ Approved Resolution 23-R-19 awarding the bid for the Cassel Hills Golf Course split rail fence project to Allied Fence Builders of Dayton in the amount of \$26,675.
- ✔ Approved Resolution 23-R-20 authorizing the replacement of a mast arm pole and signal components for the traffic signal at National Road and Peters Pike. This signal was damaged by a commercial vehicle. The price of \$30,500.66 includes payment of \$4,668.66 for an emergency repair made by Capital Electric Line Builders. The City anticipates these costs will be recovered by the insurance company of the driver who was at fault.
- ✔ Approved, in its first reading, Ordinance 23-05 amending the Cassel Hill's Swimming Pool Fee Schedule and Operational Policy. A second reading will occur on March 20.
- ✔ Approved as an emergency in its second reading, Ordinance 23-04 assessing properties for delinquent accounts related to storm water fees, trash collection, delinquent sewer & water, and weed cutting.
- ✔ Tabled a variance request to allow roof-mounted solar panels facing the right-of-way at 825 Olde Farm Court until June 19, 2023.
