

Council Action

In an effort to increase awareness and understanding, this publication was created to detail and explain the actions of the Vandalia City Council. We hope this promotes a better understanding of the role Council plays in keeping Vandalia a great place to live, work and play.

Council took the following actions at the Monday, May 15, 2023, meeting:

- ✔ Mayor Herbst presented a proclamation to the Division of Police for National Police Week.
- ✔ Mayor Herbst presented a proclamation to the Division of Public Works for Public Works Week.
- ✔ City Manager Wendt introduced and gave the oath of office to Firefighter/Paramedic/Inspectors Amanda Everett and Sean Tyler Day.
- ✔ Waived a hearing regarding the liquor permit for Aldi.
- ✔ Approved Resolution 23-R-36 authorizing the City Manager to enter into a contract with Place Dynamics, LLC. for a Market Feasibility Study for Job Creation and Revitalization Area No. 1.
- ✔ Approved Resolution 23-R-37 authorizing the City Manager to enter into an agreement with OHM Advisors for the Robinette Park Design Project.
- ✔ Approved Resolution 23-R-38 authorizing the City Manager to enter into an agreement with Vandalia-Butler City Schools regarding joint use of facilities.
- ✔ Approved Resolution 23-R-39 awarding the City's street resurfacing contract to Barrett Paving Materials at the lowest and best bid price of \$818,213.02.
- ✔ Approved Resolution 23-R-40 authorizing the purchase of portable and mobile MARCS radios for the Division of Fire. This is phase 2 of a radio upgrade that began in 2022.
- ✔ Approved Resolution 23-R-41 awarding the bid for the replacement of sanitary sewer at I-75 and National Road to C.G. Construction & Utilities, Inc. as the lowest and best bid price of \$ 149,692.
- ✔ Approved Resolution 23-R-42 authorizing a contract with the Ohio Department of Transportation to partner on the traffic signal project at I-75 and Northwoods Boulevard. Our local share of the construction cost is \$60,060.
- ✔ Approved Resolution 23-R-43 authorizing the purchase of Rapid Flashing Beacons for four locations in the City at a cost not to exceed \$39,800.
- ✔ Approved, in its first reading, Ordinance 23-11 approving a payment of debt for the Land Acquisition Note for Stonequarry Crossings, and issuance of a new Note for the remaining outstanding balance. The debt is scheduled to be paid in full in 2036.
- ✔ Approved, in its first reading, Ordinance 23-12 approving a payment of debt for the Bond Anticipation Note for the 2016 Fire Engine and the 2021 Ladder Truck, and issuance of a new Note for the remaining outstanding balance. This debt is scheduled to be paid in full in 2026 and 2031.
- ✔ Approved, in its first reading, Ordinance 23-13 adopting a new schedule of fees for water and sewer permits and providing for an annual adjustment.
- ✔ Approved, in its first reading, Ordinance 23-14 adopting a new schedule of fees for permits and inspections and providing for an annual adjustment.
- ✔ Approved, as an emergency, Ordinance 23-10 assessing properties for delinquent accounts related to storm water fees, trash collection, and delinquent sewer & water.
- ✔ Approved a conditional use to allow a day care at 732 W. National Road with the condition that no outdoor play area shall be constructed as part of the use.
- ✔ Approved a variance request to allow a 128 square foot awning to encroach into the front setback at 831 Roxana Drive.
