RESOLUTION 23-R-44

A RESOLUTION AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO SUBMIT AN APPLICATION FOR COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS FOR A PLAYGROUND STRUCTURE AND SAFETY SURFACE AT ROBINETTE PARK AND AUTHORIZING ADDITIONAL ACTION AS NECESSARY WITH RESPECT TO THE PROJECT

The resolution, which bears the foregoing title, was unanimously approved Monday, June 19, 2023, by the Council of the City of Vandalia. It authorizes the City Manager or his designee to submit an application for Community Development Block Grant funds for a playground structure and safety surface at Robinette Park and authorizing additional action as necessary with respect to the project. The ordinance, which bears the foregoing title, was unanimously approved in the emergency reading Monday, June 19, 2023, by the Council of the City of Vandalia. It provides for the issuance and sale of notes in the maximum principal amount of \$1,399,000, in anticipation of the issuance of bonds, to provide moneys for the Retirement of the City's outstanding taxable Land Acquisition Notes, Series 2022, and declaring an emergency. AN ORDINANCE PROVIDING FOR THE ISSUANCE AND SALE OF NOTES IN THE MAXIMUM AGGREGATE PRINCIPAL AMOUNT OF \$1,241,000, IN ANTICIPATION OF THE ISSUANCE OF BONDS, TO PROVIDE MONEYS FOR THE RETIREMENT OF THE CITY'S OUTSTANDING VARIOUS PURPOSE NOTES, SERIES 2022, AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title, was unanimously approved in the emergency reading Monday, June 19, 2023, by the Council of the City of Vandalia. It provides for the issuance and sale of notes in the maximum aggregate principal amount of \$1,241,000, in anticipation of the issuance of bonds, to provide moneys for the Retirement of the City's outstanding various purpose Notes, Series 2022, and declaring an emergency. ORDINANCE 23-13

AN ORDINANCE AMENDING CHAPTER 1040, WATER AND SEWER PERMITS, SECTION 1040.02 PERMIT AND ENTRY FEES OF THE VANDALIA CODIFIED ORDINANCES BY ADOPTING A NEW SCHEDULE OF FEES FOR WATER AND SEWER PERMITS AND PROVIDING FOR AN ANNUAL ADJUSTMENT

The ordinance, which bears the foregoing title, was unanimously approved in the second reading Monday, June 19, 2023, by the Council of the City of Vandalia. It amends Chapter 1040, Water and Sewer Permits, Section 1040.02 permit and entry fees of the Vandalia Codified Ordinances by adopting a new schedule of fees for water and sewer permits and providing for an annual adjustment. ORDINANCE 23-14
