RESOLUTION 23-R-47

A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE PURCHASE OF COMPUTERS, LAPTOPS, TABLETS AND RELATED EQUIPMENT FOR THE 2023 COMPUTER UPGRADE PROJECT FROM DELL INC AT A TOTAL PRICE OF \$108,188.73

The resolution, which bears the foregoing title, was unanimously approved Monday, July 17, 2023, by the Council of the City of Vandalia. It waives the formal bidding process and authorizing the purchase of computers, laptops, tablets and related equipment for the 2023 computer upgrade project from Dell Inc at a total price of \$108,188.73. A RESOLUTION AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S) AND AUTHORIZING ADDITIONAL ACTION AS NECESSARY FOR THE CITY TO PARTICIPATE IN SUCH PROGRAMS WITH RESPECT TO THE TIONDA DRIVE, MOSSVIEW DRIVE AND RANCHVIEW DRIVE WATERMAIN REPLACEMENT PROJECT

A RESOLUTION WAIVING COMPETITIVE BIDDING AND AUTHORIZING THE PURCHASE OF THREE 2024 FORD SUV PATROL UTILITY VEHICLES FROM BEAU TOWNSEND FORD FOR A COST OF UP TO \$55,000 EACH FOR A TOTAL PURCHASE PRICE NOT TO EXCEED \$165,000 AND DECLARING THE THREE 2020 FOR UTILITY PATROL VEHICLES AS SURPLUS PROPERTY

The resolution, which bears the foregoing title, was unanimously approved Monday, July 17, 2023, by the Council of the City of Vandalia. It waives competitive bidding and authorizing the purchase of three 2024 Ford SUV patrol utility vehicles from Beau Townsend Ford for a cost of up to \$55,000 each for a total purchase price not to exceed \$165,000 and declaring the three 2020 for utility patrol vehicles as surplus property. It amends part four traffic code of the Codified Ordinances of the City of Vandalia by amending Chapter 434 by adding a new section 434.012 dealing with driving while texting as a primary offense. ORDINANCE 23-17

AN ORDINANCE REZONING 72.628 ACRES OF CITY OWNED LAND LOCATED ON WEBSTER STREET SOUTH OF PARK CENTER DRIVE AND AMENDING THE ZONING MAP OF THE CITY
