RESOLUTION 23-R-54

RESOLUTION AWARDING THE BID FOR REFUSE & RECYCLING COLLECTION IN THE CITY OF VANDALIA FOR CALENDAR YEARS 2024-2028, REQUESTED BY THE DEVELOPMENT & ENGINEERING SERVICES DEPARTMENT, TO RUMPKE WASTE & RECYCLING AT THEIR PROPOSED COSTS AS THE LOWEST AND BEST BIDDER

The resolution, which bears the foregoing title, was unanimously approved Tuesday, September 5, 2023, by the Council of the City of Vandalia. It awards the bid for Refuse & Recycling Collection in the City of Vandalia for calendar years 2024-2028, requested by the Development & Engineering Services Department, to Rumpke Waste & Recycling at their proposed costs as the lowest and best bidder. ORDINANCE NO. 23-22

AN ORDINANCE PROVIDING FOR THE ISSUANCE AND SALE OF BONDS IN THE MAXIMUM PRINCIPAL AMOUNT OF \$6,000,000 FOR THE PURPOSE OF PAYING THE COSTS OF IMPROVING THE MUNICIPAL PUBLIC TRANSPORTATION SYSTEM, INCLUDING NATIONAL ROAD (U.S. 40) AND DOG LEG ROAD, BY CONSTRUCTING, RECONSTRUCTING, EXTENDING, OPENING, WIDENING, GRADING, DRAINING, CURBING, PAVING AND RESURFACING, AND SITE PREPARATION, INSTALLING STORM WATER, SANITARY SEWER AND WATER IMPROVEMENTS, AND ACQUIRING ANY NECESSARY INTERESTS IN REAL PROPERTY, TOGETHER WITH ALL INCIDENTAL WORK AND RELATED APPURTENANCES THERETO, AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title, was tabled 7-0 until September 18, 2023, by the Council of the City of Vandalia on Tuesday September 5, 2023. It would have provided for the issuance and sale of Bonds in the maximum principal amount of \$6,000,000 for the purpose of paying the costs of improving the Municipal Public Transportation System, including National Road (U.S. 40) and Dog Leg Road, by constructing, reconstructing, extending, opening, widening, grading, draining, curbing, paving and resurfacing, and site preparation, installing storm water, sanitary sewer and water improvements, and acquiring any necessary interests in Real Property, together with all incidental work and related appurtenances thereto, and declaring an emergency. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the City Council of Vandalia, Ohio on Monday, September 18, 2023 at 7:00 p.m., in Council Chambers, 333 J.E. Bohanan Drive, Vandalia, Ohio. A copy of this ordinance is available for inspection at the office of the Clerk of Council, City of Vandalia, Ohio.
