ORDINANCE NO. 23-24

AN ORDINANCE CREATING A CITY FIRE INSURANCE FUND, PROVIDING A POLICY RELATING TO SUCH FUND, AND CODIFYING SAME AS SECTION 234.10 OF THE VANDALIA CODIFIED ORDINANCES

The ordinance, which bears the foregoing title, was unanimously approved in the first reading Monday, October 2, 2023, by the Council of the City of Vandalia. It creates a City Fire Insurance Fund, providing a policy relating to such fund, and codifying same as section 234.10 of the Vandalia codified ordinances. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the City Council of Vandalia, Ohio on Monday, October 16, 2023 at 7:00 p.m., in Council Chambers, 333 J.E.
