



Council Action

In an effort to increase awareness and understanding, this publication was created to detail and explain the actions of the Vandalia City Council. We hope this promotes a better understanding of the role Council plays in keeping Vandalia a great place to live, work and play.

Council took the following actions at the Monday, November 6, 2023, meeting:

- ✔ The Military Order of the Purple Heart conducted a ceremony and Mayor Herbst gave a Proclamation proclaiming Vandalia a Purple Heart City.
- ✔ City Manager Wendt and Chief Kurt Althouse presented Officers Clymer and Nelson with a Medal of Valor for their life saving actions taken at a house fire on May 13, 2023.
- ✔ City Engineer, Ben Borton, presented on the National Road truck traffic counts.
- ✔ Approved Resolution 23-R-70 approving the Webster Street Plat for 72.628 acres of land.
- ✔ Approved Resolution 23-R-71 approving the LBD Enterprises Plat for 2.891 -acres of land and dedication of 0.273 acres of public right-of-way.
- ✔ Approved Resolution 23-R-72 authorizing the City Manager to enter into an agreement with Dayton Power & Light (AES Ohio) to provide an easement for the replacement of poles and transmission lines on Tri-Cities Wastewater Authority owned land near the CSX railroad.
- ✔ Approved Resolution 23-R-73 authorizing the City Manager to enter into an agreement with Rangeline Tapping Services to install two 16" water valves along a trunk watermain for \$66,000.
- ✔ Tabled, in its first reading, Ordinance 23-29 amending Chapter 208, Purchasing, of the Codified Ordinances.
- ✔ Approved Ordinance 23-30, in it's first reading, approving the editing and inclusion of certain ordinances and resolutions passed by Council since the last update. This update will codify all pertinent legislation passed by Council during 2022, as well as incorporate amendments to the Ohio Revised Code.
- ✔ Approved, in its second reading, Ordinance 23-26 rezoning 126.812 acres +/- to Public Facilities and Office/Industrial Park. The location of these parcels is as follows: 810 Northwoods Blvd., 815 Foley Dr., Webster Street approximately 500 feet south of Park Center Blvd., the intersection of Old Springfield and Old Canal Roads, and the southeast end of Johnson Station Rd.
- ✔ Approved, in its second reading, Ordinance 23-27 assessing the cost of razing the structures at 841 Spartan Avenue and 6325 Shady Knoll to the property owners and have the County Auditor place the amounts due upon the tax list and duplicate.
- ✔ Approved, in its second reading as an emergency, Ordinance 23-28 authoring appropriations for FY 2024.
- ✔ Approved a variance to allow a 1,200 square foot detached garage at 1340 S. Dixie Drive.
- ✔ Approved a variance to allow a 676 square foot detached garage at 570 O'Hara Court with one condition.
