RESOLUTION 23-R-70

A RESOLUTION APPROVING THE WEBSTER STREET PLAT

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH DAYTON POWER & LIGHT, (AKA AES OHIO) FOR THE PURPOSE OF PROVIDING A UTILITY EASEMENT FOR UTILITY POLE REPLACEMENT AND ELECTRIC LINE WORK ON PROPERTY CO-OWNED BY THE CITIES OF HUBER HEIGHTS, VANDALIA, AND TIPP CITY FOR USE BY THE TRI-CITIES NORTH REGIONAL WASTEWATER AUTHORITY

The resolution, which bears the foregoing title, was unanimously approved Monday, November 6, 2023, by the Council of the City of Vandalia. It authorizes the City Manager to enter into an agreement with Dayton Power & Light, (aka AES Ohio) for the purpose of providing a utility easement for utility pole replacement and electric line work on property co-owned by the cities of Huber Heights, Vandalia, and Tipp City for use by the Tri-Cities North Regional Wastewater Authority. A RESOLUTION AUTHORIZING THE CITY MANAGER TO WAIVE THE FORMAL BIDDING AND ENTER INTO AN AGREEMENT FOR INSTALLATION OF TWO WATER VALVES ON THE CITY'S 16" WATERMAIN

ORDINANCE 23-30

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AND A RESOLUTION AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES; PROVIDING FOR THE ADOPTION AND PUBLICATION OF NEW MATTER IN THE UPDATED AND REVISED CODIFIED ORDINANCES; AND REPEALING ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH

The ordinance, which bears the foregoing title, was unanimously approved in the first reading Monday, November 6, 2023, by the Council of the City of Vandalia. It approves the editing and inclusion of certain ordinances and a resolution as parts of the various component codes of the codified ordinances; providing for the adoption and publication of new matter in the updated and revised codified ordinances; and repealing ordinances and resolutions in conflict therewith A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the City Council of Vandalia, Ohio on Monday, November 20, 2023 at 7:00 p.m., in Council Chambers, 333 J.E. ORDINANCE 23-26

ORDINANCE 23-28

It will make appropriations for current expenses and other expenditures of the City of Vandalia, Ohio during the calendar year ending December 31, 2024 and declaring an emergency.
