RESOLUTION 24-R-06

A RESOLUTION AUTHORIZING THE PURCHASE OF WATER METERS AND APPURTENANCES FROM BUCKEYE STATE PIPE & SUPPLY COMPANY, INC. AT A COST NOT TO EXCEED \$500,000
