RESOLUTION 24-R-17

A RESOLUTION AWARDING THE BID FOR ASPHALTIC CONCRETE, REQUESTED BY THE PUBLIC WORKS DEPARTMENT, TO BARRETT PAVING MATERIALS IN THE AMOUNT OF \$78.00/TON FOR TYPE II ASPHALT AND \$77.00/TON FOR TYPE I ASPHALT AS THE LOWEST AND BEST BID

ORDINANCE 24-03

AN ORDINANCE AMENDING CHAPTER 1482 OF THE VANDALIA CODIFIED ORDINANCES BY PROVIDING A POLICY RELATED TO THE STORAGE OF CONSTRUCTION MATERIALS ON ALL OF THE PRIVATE PROPERTY WITHIN THE CITY AND CODIFYING SAME AS SECTION 1482.24 OF THE VANDALIA CODIFIED ORDINANCES

The ordinance, which bears the foregoing title, was unanimously approved in the first reading Monday, March 18, 2024, by the Council of the City of Vandalia. It amends Chapter 1482 of the Vandalia Codified Ordinances by providing a policy related to the storage of construction materials on all of the private property within the City and codifying same as Section 1482.24 of the Vandalia Codified Ordinances. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the City Council of Vandalia, Ohio on Monday, April 1, 2024, at 7:00 p.m., in Council Chambers, 333 J.E. AN ORDINANCE AMENDING CHAPTER 1064, CEMETERIES, OF THE CODIFIED ORDINANCES OF THE CITY OF VANDALIA, OHIO, BY ESTABLISHING NEW RATES FOR CEMETERY OPERATIONS

It amends Chapter 1064, Cemeteries, of the Codified Ordinances of the City of Vandalia, Ohio, by establishing new rates for cemetery operations. Ohio.
