## **Council Action**

In an effort to increase awareness and understanding, this publication was created to detail and explain the actions of the Vandalia City Council. We hope this promotes a better understanding of the role Council plays in keeping Vandalia a great place to live, work and play.

## Council took the following actions at the Monday, April 15, meeting:

- City Manager Wendt introduced and administered the Oath of Office to Fire Fighter/Paramedic/Inspector Haley Lippencott who began full time employment April 3, 2024.
- Mayor Herbst and Councilmembers presented a proclamation to Human Resources Manager Missy Pruszynski recognizing her retirement from the City of Vandalia after 37 years of combined service.
- Approved Resolution 24-R-26, authorizing the City Manager to enter into a contract with Medicount Management Inc., to perform emergency medical services (EMS) billing services for the Division of Fire.
- Approved Resolution 24-R-27, authorizing the City Manager to enter into an agreement with A To Z Asphalt of Vandalia, Ohio for the Helke Park Sport Court Maintenance Project in an amount of \$58,770.
- Approved Resolution 24-R-28, awarding the bid and authorizing the City Manager to enter into a contract with Muffler Brothers for vehicle maintenance and mechanical service for police vehicles.
- Approved Resolution 24-R-29, authorizing the Law Director to register an objection to a liquor permit renewal and requesting a hearing.
- Approved Resolution 24-R-30, authorizing additional cooperation with the Ohio Department of Transportation regarding improvements to Webster Street from Stop Eight Road to Little York Road, being PID No. 116880.
- Approved, in its first reading, Ordinance 24-08, amending the text of the Vandalia Zoning Code relating to signs in the Vandalia City Center Overlay.
- Approved Ordinance 24-06, revising appropriations for current expenses and other expenditures of the City of Vandalia, Montgomery County, Ohio during the calendar year ending December 31, 2024, and amending Ordinance 23-28, and declaring an emergency.
- Approved Ordinance 24-07, approving individual assessment amounts and directing the finance director or her designee to certify the amounts to the County Auditor for collection and declaring an emergency.
- ₩ Approved a variance to the side yard setback requirement for the property located at 1333 Helke Road.
- ₩ Denied a conditional use for the construction of a hotel for the property located at 3675 Wyse Road.
- Entered into Executive Session to discuss with the City Attorney pending or imminent litigation, and to consider the employment of an employee.
