RESOLUTION 24-R-31

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH A TO Z ASPHALT OF VANDALIA, OHIO FOR THE SPORTS COMPLEX AND RECREATION CENTER ASPHALT MAINTENANCE PROJECT IN AN AMOUNT OF \$148,774

The resolution, which bears the foregoing title, was unanimously approved Monday, May 6, 2024, by the Council of the City of Vandalia. It authorizes the City Manager to enter into an agreement with A to Z Asphalt of Vandalia, Ohio for the Sports Complex and Recreation Center Asphalt Maintenance Project in an amount of \$148,774.
