RESOLUTION 24-R-45

A RESOLUTION AWARDING THE BID FOR THE TIONDA, MOSSVIEW, AND RANCHVIEW DRIVE WATERMAIN REPLACEMENT & RESURFACING PROJECT, REQUESTED BY DEVELOPMENT AND ENGINEERING SERVICES, TO M&T EXCAVATING AT THE LOWEST AND BEST BID PRICE OF \$1,685,751.00
