### **RESOLUTION 25-R-16**

A RESOLUTION AUTHORIZING THE PURCHASE OF FOURTEEN (14) PANASONIC MOBILE DATA TERMINALS AND RELATED EQUIPMENT, REQUESTED BY THE IT DEPARTMENT, FROM CDW-G, LLC, AT GOVERNMENT PROCUREMENT CONTRACT PRICING AMOUNTS TOTALING \$67,573.14

The resolution, which bears the foregoing title, was unanimously approved Monday, March 17, 2025, by the Council of the City of Vandalia. It authorizes the purchase of fourteen (14) Panasonic Mobile Data Terminals and related equipment, requested by the IT department, from CDW-G, LLC, at government procurement contract pricing amounts totaling \$67,573.14.
