**RESOLUTION 25-R-22**

**A RESOLUTION DECLARING THE OFFICIAL INTENT AND REASONABLE EXPECTATION OF THE CITY OF VANDALIA ON BEHALF OF THE STATE OF OHIO (THE BORROWER) TO REIMBURSE ITS WATER FUND FOR THE CD15AB / CD16AB, TIONDA, RANCHVIEW & MOSSVIEW DRIVE WATERMAIN REPLACEMENT WITH THE PROCEEDS OF TAX EXEMPT DEBT OF THE STATE OF OHIO**

The resolution, which bears the foregoing title, was unanimously approved Monday, April 21, 2025, by the Council of the City of Vandalia. It declares the official intent and reasonable expectation of the City of Vandalia on behalf of the State of Ohio (the borrower) to reimburse its Water Fund for the CD15AB / CD16AB, Tionda, Ranchview & Mossview Drive watermain replacement with the proceeds of tax exempt debt of the State of Ohio. **ORDINANCE 25-04**

**AN ORDINANCE AMENDING SECTIONS 878.03, 878.04 AND 878.06 OF CHAPTER 878 OF THE CODIFIED ORDINANCES OF THE CITY OF VANDALIA REGARDING HOTEL REGISTRATION**

It approves individual assessments amounts and directs the Finance Director or her designee to certify the amounts to the county auditor for collection and declaring an emergency.
