### **RESOLUTION 25-R-42**

# A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A DEBT COLLECTION AGREEMENT WITH THE OHIO ATTORNEY GENERAL'S OFFICE FOR THE COLLECTION OF DELINQUENT TAX DEBT

It authorizes the City Manager to enter into a debt collection agreement with the Ohio Attorney General's Office for the collection of delinquent tax debt.
