RESOLUTION 20-R-10

A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE PURCHASE OF THIRTEEN PANASONIC CF-31 TOUGHBOOK MOBILE COMPUTERS REQUESTED BY THE DIVISION OF POLICE, TO ARC ACQUISITION US, INC. AT THE STATE OF OHIO COOPERATIVE PURCHASING AGREEMENT CONTRACT PRICING AMOUNT
