This ordinance combines the Vandalia Cultural Arts Committee and Public Arts In Vandalia Committee and forms a single committee; authorizes the city manager to work with the Dayton Foundation and Vandalia Butler Foundation in order to combine the Vandalia Cultural Arts Fund and Public Arts in Vandalia Fund into a new single fund for the new combined committee.
