RESOLUTION NO. 17-R-82

A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH TOPP SHAPE ENTERPRISES, INC. FOR CERTAIN GOLF COURSE BUNKER RENOVATIONS IN THE AMOUNT OF \$39,250

The resolution, which bears the foregoing title, was unanimously adopted on Monday, October 16, 2017 by the Council of the City of Vandalia. It waives the formal bidding process and authorizes the city manager to negotiate and enter into an agreement with Topp Shape Enterprises, Inc. for certain golf course bunker renovations in the amount of \$39,250. The resolution, which bears the foregoing title, was unanimously adopted on Monday, October 16, 2017 by the Council of the City of Vandalia. It authorizes the city manager to join a coalition of municipalities retaining special counsel for purposes of initiating litigation to challenge the constitutionality of amendments to chapter 718 of the Ohio Revised Code relating to municipal income tax.
