RESOLUTION NO. 17-R-93

A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE PURCHASE OF A LUCAS CPR DEVICE, REQUESTED BY THE FIRE DEPARTMENT, FROM PHYSIO-CONTROL, INC. IN THE AMOUNT OF \$13,148

The resolution, which bears the foregoing title, was unanimously adopted on Monday, November 20, 2017 by the Council of the City of Vandalia. It waives the formal bidding process and authorizes the purchase of a Lucas CPR device, requested by the fire department, from Physio-Control, Inc. in the amount of \$13,148. ORDINANCE 17-28

AN ORDINANCE REZONING THE PROPERTY GENERALLY LOCATED AT THE NORTHWEST CORNER OF BUTTERCUP AVENUE AND HELKE ROAD FROM RESIDENTIAL SINGLE-FAMILY 4 “RSF-4” TO NEIGHBORHOOD BUSINESS “NB” AND AMENDING THE ZONING MAP OF THE CITY

The ordinance which bears the foregoing title was unanimously adopted in its second reading Monday, November 20, 2017, by the Council of the City of Vandalia. It rezones the property generally located at the northwest corner of Buttercup Avenue and Helke Road from residential single-family 4 “RSF-4” to neighborhood business “NB” and amending the zoning map of the city. AN ORDINANCE APPROVING A MAJOR AMENDMENT FOR PHASE 4 OF THE VILLAGE BROOKE ESTATES BEING PROPERTY GENERALLY LOCATED AT THE NORTHWEST CORNER OF BUTTERCUP AVENUE AND HELKE ROAD IN THE RESIDENTIAL SINGLE-FAMILY 4 DISTRICT WITH A PUD OVERLAY

The ordinance which bears the foregoing title was unanimously adopted in its second reading Monday, November 20, 2017, by the Council of the City of Vandalia. It approves a major amendment for Phase 4 of the Village Brooke Estates being property generally located at the northwest corner of Buttercup Avenue and Helke Road in the residential single-family 4 district with a PUD overlay. ORDINANCE 17-32

AN ORDINANCE AUTHORIZING ARLENE SETZER, MAYOR OF THE CITY OF VANDALIA, TO ACCEPT THE RETIREMENT OF JON CRUSEY AS CITY MANAGER AND TO REHIRE HIM BY ENTERING INTO A NEW EMPLOYMENT CONTRACT FOR THE POSITION OF CITY MANAGER, ESTABLISHING THE SALARY OF THE CITY MANAGER PROVIDING FOR A MERIT BONUS AND DECLARING AN EMERGENCY

The ordinance which bears the foregoing title was adopted by a vote of 6-1 in an emergency reading Monday, November 20, 2017, by the Council of the City of Vandalia. It authorizes Arlene Setzer, Mayor of the city of Vandalia, to accept the retirement of Jon Crusey as city manager and to rehire him by entering into a new employment contract for the position of city manager, establishing the salary of the city manager providing for a merit bonus and declaring an emergency. ORDINANCE 17-33

AN ORDINANCE AMENDING THE VANDALIA ZONING CODE TO PROVIDE FOR MULCH PROCESSING FACILITIES AS A CONDITIONAL USE
