RESOLUTION NO. 17-R-94

FINAL RESOLUTION ENACTED BY THE CITY OF VANDALIA FOR OHIO FOR POD ODOT PROJECT , 103062 BEING THE RESURFACING AIRPORT ACCESS ROAD FROM VANDALIA NORTH CORP. LIMIT TO VANDALIA SOUTH CORP. LIMIT
