RESOLUTION 17-R-95

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE MONTGOMERY COUNTY PUBLIC DEFENDER FOR PUBLIC DEFENDER SERVICES

The resolution, which bears the foregoing title, was unanimously adopted on Monday, December 18, 2017 by the Council of the City of Vandalia. This resolution authorizes the city manager to enter into an agreement with the Montgomery County Public Defender for public defender services. RESOLUTION 17-R-97

A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT TO AN AGREEMENT FOR ELECTRIC GENERATION SUPPLY WITH A COMPETITIVE RETAIL ELECTRIC SERVICE PROVIDER

The resolution, which bears the foregoing title, was unanimously adopted on Monday, December 18, 2017 by the Council of the City of Vandalia. This resolution waives the formal bidding process and authorizes the city manager to execute amendment to an agreement for electric generation supply with a competitive retail electric service provider. AN ORDINANCE AMENDING SECTIONS 1040.04, .05 AND .06 OF CHAPTER 1040 “WATER AND SEWER PERMITS”; SECTIONS 1042.05, .10, .13, .14 AND .26 OF CHAPTER 1042 “WATER GENERALLY”; SUBSECTIONS 1044.06(b) AND 1044.06(g), AND SUBSECTION 1044.07(a), OF CHAPTER 1044 “SEWER GENERALLY”; SECTIONS 1045.02, .26 AND .28 OF CHAPTER 1045 “STORM WATER CHARGE GENERALLY”; SECTIONS 1060.08 AND .09 OF CHAPTER 1060 “GARBAGE AND RUBBISH COLLECTION AND DISPOSAL” OF THE CODIFIED ORDINANCES OF THE CITY OF VANDALIA AND CREATING CHAPTER 1049, “UTILITY BILLING AND COLLECTION” ALL REGARDING DEPOSITS, BILLING, COLLECTIONS, PENALTIES RELATING TO UTILITIES

The ordinance which bears the foregoing title was unanimously adopted in its second reading Monday, December 18, 2017, by the Council of the City of Vandalia. This ordinance amends sections 1040.04, .05 and .06 of chapter 1040 “water and sewer permits”; sections 1042.05, .10, .13, .14 and .26 of chapter 1042 “water generally”; subsections 1044.06(b) and 1044.06(g), and subsection 1044.07(a), of chapter 1044 “sewer generally”; sections 1045.02, .26 and .28 of chapter 1045 “storm water charge generally”; sections 1060.08 and .09 of chapter 1060 “garbage and rubbish collection and disposal” of the codified ordinances of the city of Vandalia and creating chapter 1049, “utility billing and collection” all regarding deposits, billing, collections, penalties relating to utilities. ORDINANCE 17-35

AN ORDINANCE TO REVISE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF VANDALIA, MONTGOMERY COUNTY, OHIO DURING THE CALENDAR YEAR ENDING DECEMBER 31, 2017, AND AMENDING ORDINANCE 16-34 AND DECLARING AN EMERGENCY

The ordinance which bears the foregoing title was adopted by a vote of 7-0 in an emergency reading Monday, December 18, 2017, by the Council of the City of Vandalia. It revises appropriations for current expenses and other expenditures of the city of Vandalia, Montgomery County, Ohio during the calendar year ending December 31, 2017, and amending ordinance 16-34 and declaring an emergency.
