RESOLUTION 17-R-27

A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A LETTER OF UNDERSTANDING WITH THE UNITED STATES AIR AND TRADE SHOW

The resolution, which bears the foregoing title, was unanimously adopted on Monday, March 20, 2017 by the Council of the City of Vandalia. It authorizes the city manager to execute a letter of understanding with the United States Air and Trade Show. A RESOLUTION TO ENGAGE SPECIAL LEGAL COUNSEL FOR THE PURPOSE OF JOINING IN LEGAL ACTION REGARDING THE CONSTITUTIONALITY OF SUBSTITUTE SENATE BILL 331

It revises appropriations for current expenses and other expenditures of the City of Vandalia, Montgomery County, Ohio during the calendar year ending December 31, 2017, and amending Ordinance 16-34 and declaring an emergency. ORDINANCE 17-07

AN ORDINANCE REZONING PART OF THE PROPERTY LOCATED AT 3320 BENCHWOOD ROAD FROM RESIDENTIAL SINGLE-FAMILY 1 "RSF-1" TO GATEWAY BUSINESS "GB" AND AMENDING THE ZONING MAP OF THE CITY

The ordinance which bears the foregoing title was unanimously adopted in its second reading Monday, March 20, 2017, by the Council of the City of Vandalia. It will rezone part of the property located at 3320 Benchwood Road from Residential Single-Family 1 "RSF-1" to Gateway Business "GB" and amend the zoning map of the city. ORDINANCE 17-08

AN ORDINANCE AMENDING CHAPTER 668 "ANIMALS" OF THE CODIFIED ORDINANCES OF THE CITY OF VANDALIA BY ADDING SECTION 668.19 PROHIBITING THE OUTDOOR FEEDING OF ANIMALS UNDER CERTAIN CIRCUMSTANCES AND DECLARING AN EMERGENCY

The ordinance which bears the foregoing title was unanimously adopted in an emergency reading Monday, March 20, 2017, by the Council of the City of Vandalia. The ordinance amends Chapter 668 "animals" of the codified ordinances of the city of Vandalia by adding Section 668.19 prohibiting the outdoor feeding of animals under certain circumstances and declaring an emergency.
