RESOLUTION 20-R-53

A RESOLUTION AUTHORIZING AN AGREEMENT WITH CIVIC PLUS FOR THE CITY WEB SITE RE-DESIGN AND RELATED SERVICES

The resolution, which bears the foregoing title, was unanimously adopted Monday, September 28, 2020, by the Council of the City of Vandalia. It authorizes an agreement with Civic Plus for the city web site re-design and related services.
