### RESOLUTION 20-R-01

**A RESOLUTION AUTHORIZING THE PURCHASE OF A TORO GREENSMaster 3150-Q, REQUESTED BY THE PARKS AND RECREATION DEPARTMENT, THROUGH CENTURY EQUIPMENT OF CINCINNATI AT THE STATE OF OHIO CONTRACT BID PRICE OF \$35,328.46 AND REQUESTING COUNCIL DECLARE THE CURRENT 2002 TORO GREENSMaster 3100 MOWER BEING REPLACED SURPLUS PROPERTY**

The resolution, which bears the foregoing title, was unanimously adopted Monday, January 6, 2020, by the Council of the City of Vandalia. It authorizes the purchase of a Toro Greensmaster 3150-Q, requested by the Parks and Recreation Department, through Century Equipment of Cincinnati at the State of Ohio contract bid price of \$35,328.46 and requesting council declare the current 2002 Toro Greensmaster 3100 mower being replaced surplus property. ### ORDINANCE 20-01

**AN ORDINANCE REZONING 0.232 ACRES OF PROPERTY COMMONLY KNOWN AS PART OF 1 E NATIONAL ROAD FROM OFFICE-RESIDENTIAL TO OFFICE-SERVICE AND AMENDING THE ZONING MAP OF THE CITY**

The ordinance, which bears the foregoing title, was unanimously approved in its first reading Monday, January 6, 2020, by the Council of the City of Vandalia. This ordinance rezones 0.232 acres of property commonly known as part of 1 E. National Road from office-residential to office-service and amending the zoning map of the city. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the Council of the City of Vandalia, Ohio on Tuesday, January 21, 2020 at 7:00 p.m., in Council Chambers, 333 J.E.
