Mayor Herbst & City Councilmembers:

On February 10th, I had the opportunity to attend the Division of Fire's annual awards and Division meeting held at Living Word Church. Chief Follick shared the Division's 2024 accomplishments and the Division's 2025 Goals and Objectives. This year's awards recipients were EMS Person of the Year Matt Buker, Firefighter of the Year Noah vanDoesburg, Fire Officer of the Year Zach Holbrook, and Meritorious Service Award recipient Rich Morrett. I congratulate all the award recipients recognized during the ceremony. Thanks to all the employees of the Fire Division who work hard each day when responding to emergencies, participating in ongoing training drills, and completing



safety inspections and presentations to ensure the welfare and safety of our community.

A special thanks to Council for authorizing me to submit a contract to purchase the former Rite-Aid property at 10 West National Road as part of the city's revitalization. The decision to purchase this key parcel is critical for future development with our goal of finding an end-use that aligns with recommendations from the 2020 Comprehensive Plan. Property inspections are scheduled and underway to meet the 45-day closing deadline. As part of this process, Rob Cron and I recently met with two commercial developers and will be working with them to determine potential prospects for various properties in Vandalia that would align with our Comprehensive Plan. My goal is to develop some concepts and ideas for these properties that can be shared at the next Council retreat.

Representatives from Dayton Development Coalition, Jobs Ohio, and Rob Cron met with Ben Staub of BasTech Inc. BasTech has a partner company called BukTek that specializes in making suppressors or silencers for firearms. They are optimistic that this product will allow their company to grow, potentially leading to additional space needed near their current facility.



This past week, Public Works and Parks & Recreation staff removed 35 overgrown trees and stumps from the downtown area along National Road. These trees will be replaced with new trees this Spring and will continue to beautify the National Road and Dixie Drive corridor without roots harming our sidewalks and surrounding landscape.

Sara Moyer attended the second Advanced Leadership Training at the Miami Valley Communications Council on February 6th. During this session, the topic was "Challenge the Process" where the class focused on examining how well they manage change. They also discussed how participants, as leaders, can seek innovative ways to improve, experiment with new ideas, and encourage others to step outside of their comfort zones and take risks.

The Vandalia Recreation Center continues to host several exciting and fun-filled events for youth and families and these past two weeks were no exception. You can read about the various programs or events that were held at the VRC and the enjoyment experienced by those who participated.

During the past three weeks, VPD officers made eight traffic stops on commercial motor vehicles for violations. These stops resulted in eight written warnings, two of which were for parking violations, while working eight additional enforcement hours.

Elevated Ground Solutions has begun clearing and mulching up the remaining tree material in the area needed for construction at the new Public Works Facility site at 810 Northwoods Boulevard. The detailed facility design is still in progress, and we look forward to sharing it later this year.

A special "thanks" to our Public Works and Parks & Recreation employees who worked extra hours over the past two weeks to repair water main breaks and plow and salt the roadways and Vandalia facilities to clear them of snow and ice. We appreciate their dedication and commitment to keeping our roads clear and safe for all motorists.

Congratulations to Public Works Technician Joe Blosser on his retirement! Joe has acquired vast knowledge and expertise of our Public Works systems from his 32+ years of public service to the City and its residents/businesses. Joe has helped considerably with relaying his knowledge to improve our newer employees' skills. We all wish Joe the very best in his retirement.

Representatives from Dayton Development Coalition, Jobs Ohio and I met with Ben Staub of BasTech Inc. BasTech has a partner company called BukTek that specializes in making suppressors or silencers for firearms. They are optimistic that this product will allow their company to grow, potentially leading to additional space needed near their current facility.

City Planner, Mike Hammes and I met with several representatives from a company to tour the 728,000-sf facility at 1669 Capstone Way. This company would be looking to lease approximately half of the building. This location was one of their final three choices at this point and they hope to make a final decision within the next 30 days.

You and I met with two commercial development companies and look forward to engaging with at least one of the firms to begin a strategy for the redevelopment of various properties within the city.

Leann Hanf, you and I met to review some of the personnel policy manual updates that we will be bringing forward later this year.

Negotiations have begun with the Public Works Division and the Teamsters Union representatives. Several proposals have gone back and forth, and we hope to have a contract ready for approval in the not-too-distant future. The current contract expires at the end of March.

I was interviewed this week by FOX/ABC News regarding the approval to purchase the property at 10 W. National Rd. The story was aired on Wednesday night at both new outlets.

I attended the monthly I70/75 Association meeting this Friday morning at Sinclair Community College. This month's guest speaker was Julie Sullivan from the Dayton Development Coalition giving an update on regional economic development activity.

Ben Graham, Mike Hammes, you and I met to review the upcoming Board of Zoning Appeals meeting items. They have two applications that will be reviewed at their meeting on February 26th.

- 1. A variance to consider allowing the raising of chickens on a residential lot less than two acres at 995 Forest View court.
- 2. A variance to exceed the maximum sign area at 780 Northwoods Boulevard. (Kroger)

Mike Hammes attended the quarterly meeting for the Ohio Coalition of Age Friendly Communities

Kip Millikin and Ben Graham attended the Zoning Alliance Meeting hosted by Jefferson Township.


The city's Block Party Trailer is now open for reservations. We have already received two reservations for this year.

The IT Department received proposals from three companies for the 2025 Phone System Replacement Project. They are currently reviewing these proposals for completeness and alignment with project requirements. A recommendation will be presented at the March 3 study session, with a request for council approval at the March 17 regular meeting. Several proposals fall within the allocated \$170,000 budget for the project.

The IT Department has received the new large-format printer, which will be used for producing signs, wall maps, adhesive vinyl, and other high-quality prints. Located in the Municipal Building, the printer will soon be utilized to replace outdated wall maps, create event signage, and enhance public spaces within city buildings. In the coming weeks, IT staff will take time to get acclimated to the new equipment before beginning to print various materials. Once the setup and testing phase is complete, departments in need of large prints will be able to submit requests to the IT Department.

We have received the first draft of our Spring/Summer issue of the MyVandalia magazine. Staff will review the draft and submit any comments or corrections for the final version.

Congratulations to Public Works Technician Joe Blosser who has announced his retirement from the city effective February 28th. I have had the privilege of knowing and working with Joe for his entire 32+ year career with the City of Vandalia. Joe has been a great asset to the city, and we are certainly going to miss his historical knowledge of our infrastructure and his skills. - 1. There were multiple mutual aid responses this reporting period. On Feb 6th crews responded to Butler Township on the report of structure fire. Fortunately, this response resulted in the crew finding a clogged dryer vent and our Prevention Bureau reminded all those following us on social media about the importance of cleaning out and checking their dryer vents. On Feb 7th, Crews responded to a multiple alarm apartment fire in Harrison Township. The last significant mutual aid call was Feb 13th where crews assisted Huber Heights Fire Dept. on a working fire.
- Crews were dispatched to Old Springfield Road on a car into a building on Feb 7th.
 Only minor injuries and a damaged structure were found when crews arrived on scene.
- 3. Crews responded on Feb 7th to the report of a basement fire. Upon arrival, crews found light smoke. There were no injuries or damage found during this incident.
- 4. The Division of Fire held our annual awards and Division Meeting event on Monday, February 10th. The highlight of the evening is the awards and Division of Fire would like to recognize and congratulate EMS Person of the year, Matt Buker, Firefighter of the year, Noah vanDoesburg, Officer of the year, Zach Holbrook, Meritorious Service Award, Rich Morrett and all the others who were recognized for their "wins" this past year. A big thank you also to the Living Word Church for opening their doors for us to host the event.

- 2. Cold and Flu Season Has Officially Arrived! As doctors' visits begin to ramp up, don't forget to review your Summary of Benefits for your medical plan to stay well informed on what is covered, and what you may be responsible for. All of our Summary of Benefits for every line of coverage we offer can be found on our Xplore site!
- 3. The Federal NSA (No Surprise Act) Understand Your Rights Against Surprise Medical Bills. The No Surprises Act protects people covered under group and individual health plans from receiving surprise medical bills when they receive most emergency services, non-emergency services from out-of-network providers at in-network facilities, and services from out-of-network air ambulance service providers. It also establishes an independent dispute resolution process for payment disputes between plans and providers, and provides new dispute resolution opportunities for uninsured and self-pay individuals when they receive a medical bill that is substantially greater than the good faith estimate they get from the provider.

Starting in 2022, there are new protections that prevent surprise medical bills. If you have private health insurance, these new protections ban the most common types of surprise bills. If you're uninsured or you decide not to use your health insurance for a service, under these protections, you can often get a good faith estimate of the cost of your care up front, before your visit. If you disagree with your bill, you may be able to dispute the charges. Here's what you need to know about your new rights.

What are surprise medical bills?

Before the No Surprises Act, if you had health insurance and received care from an out-of-network provider or an out-of-network facility, even unknowingly, your health plan may not have covered the entire out-of-network cost. This could have left you with higher costs than if you got care from an in-network provider or facility. In addition to any out-of-network cost sharing you might have owed, the out-of-network provider or facility could bill you for the difference between the billed charge and the amount your health plan paid, unless banned by state law. This is called "balance billing." An unexpected balance bill from an out-of-network provider is also called a surprise medical bill.

People with Medicare and Medicaid already enjoy these protections and are not at risk for surprise billing.

What are the new protections if I have health insurance?

If you get health coverage through your employer, a Health Insurance Marketplace or an individual health insurance plan you purchase directly from an insurance company, these new rules will:

- Ban surprise bills for most emergency services, even if you get them out-of-network and without approval beforehand (prior authorization).
- Ban out-of-network cost-sharing (like out-of-network coinsurance or copayments) for most emergency and some non-emergency services. You can't be charged more than in-network cost-sharing for these services.
- Ban out-of-network charges and balance bills for certain additional services (like anesthesiology or radiology) furnished by out-of-network providers as part of a patient's visit to an in-network facility.
- Require that health care providers and facilities give you an easy-to-understand notice
 explaining the applicable billing protections, who to contact if you have concerns that a provider
 or facility has violated the protections, and that patient consent is required to waive billing
 protections (i.e., you must receive notice of and consent to being balance billed by an out-ofnetwork provider).

What if I don't have health insurance or choose to pay for care on my own without using my health insurance (also known as "self-paying")?

If you don't have insurance or you self-pay for care, in most cases, these new rules make sure you can get a good faith estimate of how much your care will cost before you receive it.

What if I'm charged more than my good faith estimate?

For services provided in 2022, you can dispute a medical bill if your final charges are at least \$400 higher than your good faith estimate and you file your dispute claim within 120 days of the date on your bill.

What if I do not have insurance from an employer, a Marketplace, or an individual plan? Do these new protections apply to me?

Some health insurance coverage programs already have protections against surprise medical bills. If you have coverage through Medicare, Medicaid, or TRICARE, or receive care through the Indian Health Services or Veterans Health Administration, you don't need to worry because you're already protected against surprise medical bills from providers and facilities that participate in these programs.

What if my state has a surprise billing law?

The No Surprises Act supplements state surprise billing laws; it does not supplant them. The No Surprises Act instead creates a "floor" for consumer protections against surprise bills from out-of-network providers and related higher cost-sharing responsibility for patients. So as a general matter, as long as a state's surprise billing law provides at least the same level of consumer protections against surprise bills and higher cost-sharing as does the No Surprises Act and its implementing regulations, the state law generally will apply. For example, if your state operates its own patient-provider dispute resolution process that determines appropriate payment rates for self-pay consumers and Health and Human Services (HHS) has determined that the state's process meets or exceeds the minimum requirements under the federal patient-provider dispute resolution process, then HHS will defer to the state process and would not accept such disputes into the federal process.

As another example, if your state has an All-payer Model Agreement or another state law that determines payment amounts to out-of-network providers and facilities for a service, the All-payer Model Agreement or other state law will generally determine your cost-sharing amount and the out-of-network payment rate.

4. Ohio's Surprise Billing Law (HB388) - Governor Mike DeWine signed Ohio's surprise billing law, House Bill 388 of the 133rd General Assembly, on January 7, 2021.

The law, which became effective on January 12, 2022, protects patients from receiving and paying surprise medical bills above the patient's in-network rate from health care providers for emergency care or, in certain circumstances, unanticipated out-of-network care. Cost sharing amounts, which include coinsurance, copayments, and deductibles, are limited to the patient's in-network amounts.

Before the law, patients were responsible for paying surprise medical bills, oftentimes ranging hundreds to thousands of dollars above the in-network rate, arising from these unanticipated out-of-network situations. Price and payment reconciliation is now solely between the patient's health care provider and health insurer.

The law requires the Ohio Department of Insurance to administer and enforce many of the law's provisions. It also gave the department authority to adopt rules to establish the law's operational framework.

Development & Engineering Services (DES)

<u>Dog Leg Water and Sanitary Extension Phase 2 project:</u> Still waiting on the electric meter pedestal for the lift station power from the supplier.

<u>Bikeway Connector project:</u> Brumbaugh Construction has installed most of the temporary sheet pile needed for the mechanically stabilized earth (MSE) walls next to the Taylorsville Dam. The MSE installation will begin soon.

Precision Concrete Sawcutting has started sidewalk grinding of trip hazards ¾" to 2" in height on specified streets. Property owners have been notified of this zero-cost-to-owner work.

There are eight (8) submitted and approved building permits for single-family houses in Foxfire Section 9 housing development (29 lots total). Chief Building Official Mastrino and Electrical/Building Inspectors Martin & Barnett met with home builder (Fischer Homes), who plans to break ground next week.

As part of the citywide policy goals of **Sharpen the Saw** and **Trust & Confidence**, this should give more transparency to applicants and improve customer service by streamlining the application process. Public Works Superintendent Hayslett and I attended the TCA technical committee meeting on February 12th.

On February 20th, I attended the Dayton Area Chamber of Commerce (DACC) monthly Safety Breakfast with the Experts on the topic of "Situational Awareness for Leaders" and the Miami Valley Regional Planning Commission (MVRPC) Technical Advisory Committee (TAC) monthly meeting.

Public Works (PW)

<u>New Public Works Facility (810 Northwoods Blvd):</u> Detailed design in progress. Elevated Ground Solutions has begun clearing and mulching up the remaining tree material in the area needed for construction.

Crews were called in to plow and salt the roadways on Sunday, February 16th.

Crews continued working with the Parks & Recreation Department with removing overgrown street trees on National Rd (from Perry St to Ranchview Dr) and S Perry St. Crews began hydro-excavating tree stumps as part of the planned Phase 2 replanting (39 trees) scheduled for Spring.

After much searching other the past weeks, crews located and fixed the leaking mechanical joint on the existing Ranchview water main. Leaks at mechanical joints can be very hard to locate as changing weather conditions/ground temperatures can cause the leaks to seal up and open back up periodically, unlike a typical water main break. We appreciate the public's patience while the leaking joint was located.

Crews performed the monthly water shut-offs of delinquent water accounts for the Water division of the Finance Department.

Crews continued installing new water meters inside residences/businesses.

Crews installed a 1" water tap on the 16" water main on National Rd for the new development at 267 W National Rd (Crossfit Excess).

Crews continued turning (closing/opening) watermain valves to confirm operational status throughout the City. This is an EPA requirement to perform turning on 20% of all valves each year.

Crews took monthly Municipal Industrial Pretreatment Program (MIPP) samples at Speedway, Pratt Industries, and Veolia.

Crews continued walking sanitary sewer lines in remote areas throughout the City inspecting manholes (MHs) and assuring flow is moving.

Crews inspected grease traps throughout town, making sure businesses are keeping up with the maintenance and cleaning of them bi-annually, or quarterly for restaurants. This helps prevent large build ups in the sanitary sewer which results in blockages in the mains and backups into residences/businesses.

In preparation for the 2025 sanitary sewer cured-in-place pipe (CIPP) project, crews cleared out the MHs north of Elva Ct, making sure the lining company can obtain access to the MHs for the work.

Crews performed 42 utility locates this period for Ohio 811

Crews performed 3 burials at Poplar Hill cemetery during this period.

The mechanics repaired the hydraulics for single-axle dump truck #22 and the v-box salt spreader for tandem-axle dump truck #25 while keeping up with truck inspections after snow & ice events.

The mechanics also repaired the wiring on Fire Division's Engine 2, an oil leak on Ladder 3, and coolant leak on a Medic.

Congratulations to Public Works Technician Joe Blosser on his retirement! Joe has acquired vast knowledge and expertise of our Public Works systems from his 32+ years of public service to the City and its residents/businesses. Joe has helped considerably with relaying his knowledge to improve our newer employees' skills. We all wish Joe the best with his retirement.

Negotiations have begun with Teamsters local union 957 for the 4/2025 - 4/2028 contract for PW employees. The existing contract is set to expire at the end of March.

VPD investigated no homicides, rapes, or robberies in January 2025. There were four assaults, and two domestic violence offenses reported in January 2025 compared to two assaults and seven domestic violence offenses in January 2024. Domestic violence cases were down over 71% in January 2025 compared to last January while assaults were up by two offenses.

There were no burglaries reported in January 2025 compared to one burglary reported in January 2024. In 2024, burglaries/breaking & entering incidents decreased by one offense, felony thefts decreased by 20% for a total of four offenses, auto thefts are down 25% for a total of three offenses, and misdemeanor thefts decreased by 14.3% for a total of six offenses.

There were two criminal damaging/vandalism complaints in January 2025, up from one incident last January. Criminal damaging and vandalism offenses are up 50% YTD (one incident) compared to last year for a total of two incidents this year. VPD officers have focused on being visible in residential and business areas of the city to display a police presence and prevent crime. Officers made two felony drug arrests, and three misdemeanor drug arrests in January 2025 compared to one felony drug arrest and two misdemeanor drug arrests in January 2024.

VPD made more arrests in January 2025 with four felony arrests and 24 misdemeanor arrests compared to 10 felony arrests and 14 misdemeanor arrests last January. VPD officers charged five juveniles with an offense in January 2025, compared to three juveniles in January 2024. There is a 67% increase in juvenile arrests in 2025. These charges have primarily included sex offenses, domestic violence, drug and/or alcohol violations, and thefts.



During January, VPD officers made 317 traffic stops while patrolling Vandalia's roadways, a 0.6% decrease. These stops resulted in 31 citations, 245 written warnings, 39 verbal warnings, and two stops with other dispositions. Speed citations and other citations are down over 27% in 2025, while OVI arrests remained unchanged with five arrests in January 2025, the same as January 2024. Parking citations decreased from nine parking citations in January 2024 to one parking citation in January 2025. These parking citations have primarily been violations of commercial vehicles parked in restricted areas on highway exit ramps.

VPD officers investigated 22 traffic crashes in January 2025, compared to 15 traffic crashes investigated in January 2024. Overall, traffic crashes are up 47% in 2025 compared to 2024. Officers will continue to patrol Vandalia's roadways and work traffic enforcement to keep our roadways safe and reduce traffic crashes.

Officers responded to more alarm drops than a year ago with an increase from 43 business and residential alarms in January 2024 to 60 alarms in January 2025. Overall, alarm drops for 2025 are up 40% compared to 2024.

Overall, 2025 has seen a decrease in robbery, burglary, felony & misdemeanor thefts, auto theft, and domestic violence. There has been a slight increase in assault and felony & misdemeanor drug arrests. There has been an increase in arrests and an increase in traffic crashes and alarm drops. VPD officers will remain focused on patrol activities, crime prevention, and traffic enforcement while addressing community concerns related to these areas to keep our city a great place to live, work, and play.
